Absentee ballots are allowed. Request for an absentee ballot must be made on a form created by the State Board of Elections and signed by the voter, near relative or verifiable legal guardian. All requests must be received in the Onslow County Board of Elections office by 5:00 p.m. Tuesday, November 1, 2016. The form is available at the elections office and online; <http://onslowcountync.gov/elections>. The Board of Elections will meet each Tuesday, October 18, 25 at 5:30 pm; November 1 at 5:30 pm & November 7, 2016 at 5:00 pm to approve absentee applications; and on November 17 at 3:00 pm for the purpose of approving Supplemental Absentee/ Provisional applications. **Persons wishing to register and vote after the registration deadline may appear in person at a one-stop absentee voting site, complete the voter registration application form and provide proof of residence by presenting valid documents showing current name and address.**

Any voter who wishes to change party affiliation, or who has moved since the last election must notify the Board of Elections of that change by the same date. A person may register at the Onslow County Board of Elections office, 4024 Richlands Hwy., Jacksonville, N.C. Mon. – Fri., 8:00 a.m. – 5:00 p.m. or at any DMV office or public library throughout the county.
